Presentation Ceremonies

All prize ceremonies will take place on Sunday, 14th December 2025, immediately after the conclusion of each final. Medals/trophies/other will be presented to all champions and finalists.

In accordance with Player Commitment Regulations (BWF Statute 5.3.6), all players participating in the finals of a tournament must attend the final ceremonies directly after the match or must follow the instructions given by the organisers regarding ceremony protocol.

No equipment, including rackets and flags, are allowed to be brought onto the podium. Clothing worn during the ceremony must be in accordance with the BWF GCR.
