All entries MUST only be submitted through your Member Associations. <p>For members who are having technical difficulties, kindly contact Mr. Haziq at haziq@badmintonasia.org before the Entry Deadline provided above.</p> <p>After the closing date, the BWF Online Entry System will send a notification to all participating Member Associations confirming receipt of final entries. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline. Competition Rules & Regulation	<p>Relevant Badminton World Federation Regulations shall be applicable to this competition.</p> <p>Seed Withdrawal Movement will be implemented in this tournament You may refer to BWF STATUTES General Competition Regulation 11.3</p>
Clothing & Advertising	<p>Clothing and advertising will be permitted in accordance with the competition regulations of Badminton World Federation (GCR 20 - 24).</p> <p>The player's name on the back of clothing shall be identical with the name registered as the Last Name (or an abbreviation thereof) in the BWF Player database. Last Name is defined as the family name, surname or similar name under the respective naming protocol of the Member count (GCR 23.3).</p> <p><u>MANDATORY CLOTHING REGULATIONS</u></p> <ol style="list-style-type: none"> 1. Name of the player is MANDATORY from the first day of the event. 2. From Quarter Finals onwards, doubles partners must wear clothing of the same color. 3. From Quarter Finals onwards, opposing players must wear clothing of significantly different colors.
On Court Doctor	On Court Doctor will be on duty throughout the competition at the tournament venue.
Doping Control	<p>Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.</p> <p>Athletes are responsible for any substance found in their body.
