FORMAT	<p>Men's (MS) and women's (WS) singles, men's (MD) and women's (WD) doubles and mixed doubles (XD). The maximum number of competitors accepted in the tournament is:</p> <ul style="list-style-type: none">• 64 players in men's and women's singles• 32 pairs in men's and women's doubles• 48 pairs in mixed doubles <p>No qualifications will be played before the main draw. If there are more entries for an event than will be accepted, the players/pairs will qualify for the main draw in accordance with BEC Junior Circuit Regulations 6.1.5.</p> <p>In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking.</p> <p>In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw, this particular event shall not count towards any ranking.</p> <p>Badminton Europe is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.</p>
ELIGIBLE PLAYERS	All badminton players who are eligible to play for BWF Members. Swedish Junior 2026 is exempted from the BWF Statutes, Section 5.6.1: Participation Regulations for Individual Neutral Players and Support Personnel with a Russian/Belarusian Passport. Hence, Swedish Junior in 2026 is organized without the participation of Russian or Belarusian athletes or officials, regardless of their representation as neutral Players/Support Personnel.

OTHER INFORMATION Doping Control: According to Swedish law Drug Testing might be carried out on a random basis at any time during the tournament

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
