The tournament host and hosting Member Association accepts no responsibility for withdrawals made due to late or refused visa applications.

It is the responsibility of the Member Association to apply for the necessary visas in sufficient time, and all matters should be directed to the Embassy in charge.

VISA information may be shared with the Immigration, Refugees and Citizenship Brazil's. Information collected is used to identify and coordinate the processing of visa applications and, upon request, provide organizers updates of aggregate data on the status of visa applications of event participants, within the confines of the Privacy Act and at the discretion of the Special Events Unit.

Any visa support letter issued by the tournament host does not guarantee entry into BRAZIL; the final decision is made by the Government of BRAZIL.
