Clothing & Advertising	Clothing and advertising will be permitted in accordance with the competition regulations of the Badminton World Federation. (GCR 20 - 24) The player's name on the back of clothing shall be identical with the name registered as the Last Name (or an abbreviation thereof) in the BWF Player database. Last Name is defined as the family name, surname or similar name under the respective naming protocol of the Member country. (GCR 23.3) <u>MANDATORY CLOTHING REGULATIONS</u> 1. Name of the player is MANDATORY from the first day of the event. 2. From Quarter Final onwards, doubles partners must wear clothing of the same colour and similar design. 3. From Quarter Final onwards, opposing players must wear clothing of significantly different colours.
On Court Doctor	On Court Doctor will be on duty throughout the competition at the tournament Venue.
Doping Control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
