Tournament Rules & Regulations

- 1. Entry Fees:** All entry fees must be paid online at the time of submitting the entry. Entries without payment will not be accepted.
- 2. Submission of Entries:** Entries will only be accepted through the official website: www.mbasso.in.
- 3. Withdrawal of Entries:** Entries before withdrawal shall be through MBA Website. Entries after withdrawal shall be mailed on withdrawal@mbasso.in
- 4. Rules of Play:** The tournament will be conducted in accordance with the rules and regulations of the **BWF, BAI, and MBA**. The decision of the Tournament Committee will be final and binding on all participants.
- 5. Reporting:** Each player must report to the Hon. Referee upon arrival at the venue. Any player failing to report on court when called by the Referee shall be liable to be scratched.
- 6. Fixtures:** Players must check the notice board and tournament software for details of their subsequent matches before leaving the venue.
- 7. Line Judging:** Line judges may not be appointed for all matches. Players may be required to officiate as line judges when called upon by Tournament Officials. Line judges will be provided from the Quarterfinal stage onwards.
- 8. Match Format:** All matches up to the quarter-finals will be played best of three games of 15 points (extension up to 21 points). From the quarter-finals onwards, matches will be best of three games to 21 points (extension up to 30 points)
